1.0 CONVENE

- 1.1 **Call to Order.** The meeting was called to order by President Susan K. Roth PE at 8:35 AM.
- 1.2 **Roll Call.** Secretary Mike Sosa called the role. A quorum was present. ([Attachment 1](#))
- 1.3 President Roth **welcomed visitors** and provided housekeeping announcements.
- 1.4 President-Elect Sean P. Merrell PE led Board attendees through **Pledge of Allegiance and an invocation.**
- 1.5 Communications Specialist Bailey Pattison took a **photograph of Board Members.**
- 1.6 Region 6 Director Jerry Paz PE presented **Society and Region 6 Comments.**

Discussion: Jerry Paz noted that Region 6 Board of Governors has asked the Texas Section to make CECON a regional assembly instead of just a conference for Texas. He also noted that there are currently two open governor positions (one in Texas and one in Oklahoma). The two Texas candidates are Past President Tim Newton and Vice President for Professional Affairs Tiffany Reed-Villarreal. Lastly, he showed a video that explains what **ASCE Future World Vision** is and expanded upon the video by explaining how impactful it can be as a recruiting tool for getting students interested in civil engineering as well as keeping Student Members engaged with their ASCE Membership.

- 1.7 President Susan Roth provided an **Executive Summary.**

Discussion: President Susan Roth gave a brief summary of what has happened at the Texas Section so far in 2020 - including attending the ASCE Multi-Region Leadership Conference (MRLC) in Detroit, hosting the 2021 Infrastructure Report Card (IRC) Committee Kickoff Meeting, and the 2022-2026 Strategic Planning Committee Kickoff Meeting. She also mentioned that the IRC Committee is looking for volunteers and reviewers for the energy, aviation and bridges categories. Next, she gave an update on partnership efforts with government agencies noting that the Texas Section conducted a survey on Texas Department of Transportation’s (TxDOT’s) behalf and received a good response rate from their employees. The Section has also been collaborating with the Texas Water Development Board (TWDB) in the role of technical reviewer on a variety of their documents related to the new Flood Infrastructure Finance program. Roth also thanked everyone for their responses and feedback on ASCE Code of Ethics changes and recapped the proposed changes for the Board. Lastly, she recognized Executive Director Lindsay O’Leary for passing her CAE (Certified Association Executive) exam and thanked the staff for their hard work in planning the 2020 ASCE Texas Student Symposium and continually supporting the Board.

2.0 REGULAR ITEMS FOR BOARD OF DIRECTION ACTION

Discussion: Merrell asked to add a line item to discuss the proposed changes to the CECON Planning Manual and Section Director Russell Gibson asked to include an approval of the ASCE Northeast Texas Branch Bylaws contingent on review by the Section Executive Director & Secretary.

Motion to accept agenda with the two changes. Move to approve. Seconded and passed without dissent.

2.2 The Board was asked to adopt the consent agenda.

Motion to adopt the consent agenda, no discussion. Move to adopt. Seconded and passed without dissent.

2.3 The Board was asked to approve the Slate of [Officer Nominees](#) for 2020-2021.

Motion to approve slate of 2020-21 Officer Nominees, no discussion. Move to approve. Seconded and passed without dissent.

3.0 ITEMS FOR DISCUSSION

3.1 Welcome to the 2020 ASCE Texas Student Symposium

Discussion: Vice President for Educational Affairs John Tyler recognized everyone on the planning committee for their hard work in planning the 2020 ASCE Texas Student Symposium and specifically thanked Kimberly Cornett and Heather Guillen for their time and effort. Heather Guillen gave a report on the event noting that we have 405 students, 43 competition teams, 48 professionals, and 36 sponsors in attendance which equates to \$110,775 in revenue. She also noted that we had participation from 19 schools (15 from Texas and 4 from Mexico). Next, she mentioned that we weren't quite able to hit our room block guarantee at the Sheraton so we will end up owing the hotel for those rooms we weren't able to book (about 20 nights). Lastly, she mentioned that The University of Texas at Austin will host the next year's event and that the Planning Team is currently contemplating not having a room block whatsoever or only a small block for professionals.

3.2 2021 ASCE Texas Student Symposium

Discussion: Vice President for Educational Affairs Elect Natalie Weiershausen asked the Board to save the date for April 14-17, 2021 for the next Student Symposium. She noted that the planning team is currently trying to nail down a contract with an event venue, the motto is going to be "Building the Future Together", and the theme is "Innovation". Next, she mentioned that the Austin Branch is already planning the technical PDH sessions for 2021 as well. Weiershausen thanked everyone for their hard work so far and noted how excited she is for 2021 in Austin.

Past President Art Clendenin mentioned that we need to keep 2022 on our minds because we still need to find a host chapter. O'Leary noted that there is a preliminary "host school rotation list" in existence and that can be updated and circulated around to the Faculty Advisors, Practitioner Advisors, and Section Directors. Senior Director at Large Sergio Mendez mentioned that AISC is hosting the steel bridge competition in Arlington on Sunday (the day after the Symposium) and we may need to address that for 2021. Section Director Liv Haselbach mentioned that AISC following us around could be a good thing because these events are about the students and it could mean that the steel bridge and concrete canoe competitions will get rejoined in the future.

Action – ALL to Save the Date for the 2021 ASCE Texas Student Symposium on April 14-17, 2021 in Austin

3.3 2020 Leadership Development Weekend (LDW) & Executive Committee Meeting

- July 17th – 19th at Canyon of the Eagles (Burnet, Texas)

Discussion: Merrell mentioned that LDW 2020 will be family friendly and that there will be a reception on the Friday night before the event officially kicks off on Saturday morning. He also asked everyone to Save the Date on their calendar and encourage other people from their respective Branch Boards to attend. O’Leary noted that they would like the entire Board to attend and it’s a great opportunity for outgoing officers to pass information down to their successors.

Action – ALL to Save the Date for Leadership Development Weekend 2020 on July 17-19, 2020 in Burnet

3.4 Update of Branch Goals (Section Directors)

Discussion:

- President Roth challenged Board members to begin developing an online “Toolbox” containing lessons learned and guidance on various procedures to support future ASCE leaders at both the Section and Branch levels.
- Dallas Branch is currently having an issue with their payment system for their meetings because credit card processing fees have risen. They have begun evaluating alternate options. They also have issues with taking mobile payments because the venue they have their meetings at can’t accommodate more than 2% over the registration total so they run into issues with too many people paying at the door.
- El Paso Branch is using a PayPal account and the fees are reduced because you can register as a nonprofit. El Paso is also operating a successful outreach program that is targeted towards students and younger members which has led to a high-level of engagement from younger members. They have begun a local Younger Member (YM) Group and are hosting monthly happy hour/social events. They have noticed that the drop off after college is not due to a lack of interest, but just from a lack of programming directed towards those members.
- Southeast Texas shared a story about how they once had an ethics session scheduled for their students and the speaker fell through, so they had a “meet and greet” with the students and professionals instead, and it was a huge hit. They also asked for donations and sponsorships and got unexpected level of support from local companies. It was not a formal event, instead they are positioning it as a casual hangout event. The Branch is also considering a collaboration with TxDOT to support a balsa wood bridge competition for area-high school students. President Roth requested additional information be provided after the meeting as this may be worth discussing with TxDOT at the state leadership level.
- Austin Branch said its main goal for this year was to engage membership and encourage active involvement. They have done so via social media and it has resulted in increased attendance at their monthly lunch meetings. They also hosted several Engineers Week events including an outreach event at the Science Mill and an event coordinated by the Austin YM Group. Another thing that Austin wants to focus on is providing more community volunteer opportunities for the local membership.
- Brazos is currently getting about 50-55 members at each meeting and they are trying to get a relationship with the district engineers in the area to increase attendance from TxDOT and other agency employees.
- Caprock Branch has been working with Region 6 Board Chair Jerry Paz and others to find active leadership so they can get the Branch back in action and increase support for the local student chapter (ASCE Student Chapter at Texas Tech University).
- Fort Worth Branch has about two-thirds of their current Board as younger members because they have been actively supporting the local student chapters and it has fostered a great transition from student to active professional.
- Merrell noted that the Region 6 Governors are each assigned to a Branch and can be used as a resource in times of need. They can also install Branch officers.

Action – Brower to take the lead on evaluating alternate payment processing options for events/meetings that reduce processing fees. To be included within “Toolbox” for Section and Branch leaders. Draft to be prepared by July 17, 2020 Executive Committee meeting.

Action – Alcorn to take the lead on developing guidance for hosting remote events and producing event recordings, with support from Merrell. To be included within “Toolbox” for Section and Branch leaders. Draft to be prepared by July 17, 2020 Executive Committee meeting.

Action – McCoy to lead compilation of ideas and suggestions to increase YM involvement based on her role with the Houston Branch. To be included within “Toolbox” for Section and Branch leaders. Draft to be prepared by July 17, 2020 Executive Committee meeting.

Action – Haselbach to provide additional information about the tentative TxDOT Balsa Wood Bridge Competition for High School students in the Beaumont-area.

3.5 Texas Civil Engineer (TCE)

Discussion: Mendez mentioned that the TCE is running smoothly at this point and the Editorial Committee is coordinating biweekly for articles. He noted that the committee would like to get more help from Branches as far as recaps of their activities and events. Mendez also mentioned that the subscriber list is above 600 and the Editorial Committee also needs help with Technical articles. They need a technical article ASAP and asked the Board to think if they have any recently finished project write-ups that they can repurpose.

Action – Section Directors to coordinate with their Branches to send regular updates to the Editorial Committee via Share@TexASCE.org

Action – ALL to send a recently finished project write-up to the Editorial Committee for use as a technical feature article and volunteer to serve as a technical reviewer via Share@TexASCE.org

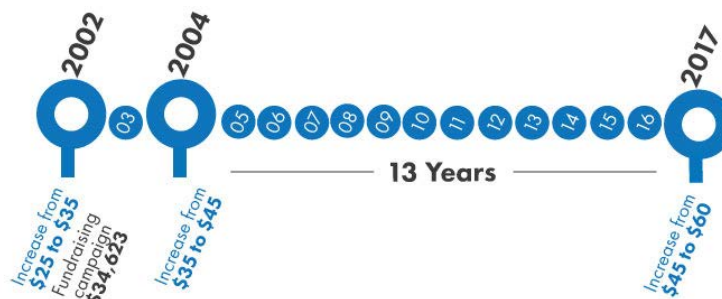
3.6 Technical Institute Chapters

Discussion: Vice President for Technical Affairs Andres Salazar noted that TWDB has been coordinating with the Texas Section’s Flood Mitigation Advisory Task Committee on a variety of documents and the committee has been providing feedback, as a technical resource. He also noted that they have received five signed copies of the CECON MOU from Institute Chapters. President Roth mentioned that John Obr is officially going to be Chair of Texas Construction Institute Chapter (TxCI). Salazar also mentioned that the Coasts, Oceans, Ports, and Rivers Institute (COPRI) had also originally responded with an interest in signing the CECON MOU, but they don’t have a Section-level Chapter so we have decided not to allow them this year. Lastly, he mentioned that the next call with all the Texas Section and Branch Institute leaders is set for March 24, 2020.

3.7 Dues Revenue Adjustments

Background:

- Timeline to implement dues increases: Approved bylaws are needed by May 31st of the year prior to which the dues increase will take effect.
- Texas Section dues over time:



- From September 18, 2019 Board meeting minutes: Board discussed setting an incremental Section dues increase every 2 to 3 years rather than having a large increase every few years.
- Status of Branch Bylaw revisions? Per September 18, 2019 Board meeting, small Branches were to update bylaws prior to this meeting. [*Reminder: In 2018, the Board recommended dues be equalized dues for all Branches, instead of \$6 for small Branches and \$10 for large Branches. (Large Branches: Austin, Dallas, Fort Worth, Houston, and San Antonio.) Branch dues amounts are reflected within Branch Bylaws*]
- Action Item: Set new deadline for bylaw revisions by small Branches.
- Future Action Item: Treasurer to evaluate Section finances and propose a schedule to increase Section dues based on current and past operating budget deficits.
- Reference: [FY2019-2020 Operating Budget](#) (Adopted 9-18-19)

Discussion: O’Leary explained that the dues increase process has been discussed over the past year or so. She noted that the process with ASCE is for the Section and Branches to approve increases separately and any increase must be approved by May 31st of the year PRIOR to the increase (i.e., May 31, 2020 for a 2021 dues increase). She also explained the last dues increase was from \$45 to \$60 in 2017 and that is caused a drop in overall membership the following year. She explained that the Section would like to avoid that situation again by switching to an incremental increase process where the dues increase a small amount on a yearly basis instead of a jump of \$15+ every 5 years or so. Treasurer Chris Nance mentioned that an increase in dues could also result in a decrease in revenue if we lose too many members. Merrell mentioned that we should strongly think about raising the dues \$5 immediately and President Roth asked for the feedback from the Board. Everyone generally agreed with that sentiment. Gibson mentioned that if we increase the Section dues too much then the total ASCE dues could end up being higher than the Texas Society of Professional Engineers (TSPE) dues - which could cause companies to switch their support from ASCE to TSPE.

3.8 Call for ASCE [Texas Section Award](#) Nominations (Clendenin)

Discussion: Clendenin noted that the deadline for 2020 Award Nomination is May 1st and is quickly approaching. He encouraged all Board Members to submit a nomination for a deserving candidate from their local Branch.

Action – ALL to nominate deserving candidates for 2020 Texas Section Awards by May 15 (deadline extension provided after the March meeting)

3.9 Section’s Governing Documents

Discussion: O’Leary noted that the Board-approved, amended Constitution (September 2019) has been provided to ASCE for approval by their Governing Documents Committee. Once approval is received, the Section will ask our subscribing members to approve it through a vote. She also noted that the Bylaws’ amendments are nearly completed, but she needs to conduct a final review before the document is provided for Board approval and subsequent Society approval. Bylaw amendments do not require a membership vote. Lastly, she mentioned that the Board-approved working version of the *Rules of Operation* (i.e., Leadership Handbook) has been updated based on Board member and Committee chair feedback. Approval of these changes was received during the meeting, via the consent agenda (Item 2.2).

3.10 Texas Civil Engineering Conference (CECON)

Discussion: Matt Singel gave an update about the proposed changes to the CECON Planning Manual, originally presented during the Winter 2020 Executive Committee Meeting. Merrell mentioned that the focus right now needs to be attracting sponsors and attendees. Singel also mentioned that we have renegotiated our contract with the event planner and expect to spend up to 40% less with our new agreement. Next,

Singel mentioned that the new CECON Committee for 2020 has been established and the roster is included within reports to the Board for this meeting. He noted that they have also developed an advisors list for the Sponsorship Chair to serve as a resource for getting in contact with companies in various parts of the state. Lastly, Singel noted that the call for speakers and topics is out (priority deadline is March 16) and the next email about sponsorship and collaborator options should be sent out within the next few weeks. Merrell suggested raising the conference registration rate soon and Weiershausen suggested adding the balsa wood competition (possible collaboration with TxDOT) to bring in other groups of attendees.
