President Elect Cornett gave a brief overview of the membership report from September 2023. President Cornett announced the 2023-2024 Membership Committee Co-Chairs: Clint Hoover and Joe Alvarez.

## **CECON 2023 Preliminary Report** 3.3

Discussion: CECON Co-Chair Stephen Archer PE noted that the revenues from exhibitors and sponsorships were just over \$120,000 and he expects there to be a small profit after the postevent accounting is finished. There were 530 attendees in total (440 on Wed, 448 on Thurs, and 429 on Fri.)

Lastly, he noted that he is excited about CECON 2024 in Frisco and ran through some of their initial programming ideas.

The big focus has been on increasing viewers through the sharing of content, which they have helped accomplish by adding an easy-to-use sharing feature at the top of each article. Lastly, they asked for help from the Board on ideas/topics they would like to see more content about.

#### 8.7 2024-25 Section Officer Nominations due Oct. 31

Discussion: Past President Attanasio PE reminded the Board that nominations for 2024-25 and encourage each Branch and State Institute Chapter to nominate at least one candidate for a position.

Houston Branch Section Director Sarah Alvarez provided comments on behalf of the Houston Branch regarding the election/nomination guidelines:

My name is Sarah Alvarez I am a Past President of the Houston Branch and the current Section Director. During the past election cycle a violation was brought to my attention and was reported to the Texas Section. I have discussed in length with the Houston Branch Board of Directors and am speaking today with the support of the board of the directors of the largest Branch of the Texas Section.

The election guidelines and contested elections were created to provide a fair election process. In the inaugural year of contested elections, [a violation occurred] and the guidelines established did not provide sufficient content to balance the infraction. The guidelines as they are written only set forth rules for all members to adhere to, but do not present a course of action other than reporting the violation to the Texas Section. Society's governing documents clearly identify disciplinary action to be taken in the event of a violation [one of which is to have] the nominee be disqualified. The Texas Section must set forth a path to ensure all future elections are fair, there is an enforceable disciplinary action, and above all provide transparency. Stakeholders should be notified of reported violations, the results and if any disciplinary action of a violation, and voting outcomes including number of votes must be reported. In addition, requiring candidates to procure a nomination from a Branch creates future potential conflicts of interest. This is in essence an unstated endorsement and as we move further into the future the campaigning rule may not be as profound and apparent as it is now. This may open the section to vulnerabilities with Branch's

endorsing through their communications, announcements to encourage their members to vote for candidate's representing their branch. Also, in an effort to prevent a conflict of interest the election guidelines must be revised to not allow candidates to give presentations on ASCE hosted webinars or events during the election cycle. We are all volunteers, we are passionate about ASCE, and we give so much of our time to this organization. If we continue to allow our organization to accept violations to occur because the impact was minimal we will allow these injustices to slowly deteriorate the core of the organization. We have a code of ethics to adhere to as members and leaders of ASCE and currently we are failing ourselves and our membership.

ASCE Houston Branch implores the Texas Section to correct it's practices to provide a fair, nondiscriminatory, and transparent process.

President Cornett expressed appreciation for Sarah reading the comments from the Houston Branch and providing potential solutions to the concerns.

Past President Travis Attanasio requested Section Director Alvarez provide what she read to Mike for the minutes and that he would take them to the nominating committee for review and discussion.
