1.7 President Cornett provided the Executive Summary.

Discussion: President Cornett thanked ExCom members for their time in attending this meeting and other industry leader events. She also reminded the group to reference the Strategic Plan throughout the year when evaluating current programs and brainstorming potential activities and/or initiatives.

Reports for Action or Discussion

2.0 Administrative Items for Executive Committee Action

2.1 The Executive Committee is asked for any changes to the agenda.

Discussion: No changes were requested and therefore no vote was taken.

2.2 The Executive Committee is asked to disclose any new potential conflicts.

Discussion: No conflicts were disclosed and therefore no vote was taken.

3.0 Items for Discussion

3.1 Welcome to 2024 Leadership Development Weekend

Discussion: President Elect Boyd welcomed everyone to LDW 2024 and provided a brief overview of what to expect for the weekend.

3.2 Section Finances

Discussion: Treasurer Glenn Goldstein PE gave an overview of the budgeting process and explained the next steps for 2024-25, including setting up a call with each officer to discuss the budget items they oversee.

Committee budgets will be due to the Treasurer by August 11 so that the overall Section budget is ready for review and approval for the Fall Board Meetings in September.

3.3 Educational Activities

Discussion: VP Educational Julia Clarke PE discussed some of the feedback received and the final budget from the 2024 Region 6 Student Symposium, noting there were about \$18,000 in profits. The 2025 Region 6 Student Symposium is set to be hosted in Stephenville by Tarleton State University.

Next, VP Educational Clarke updated the group on the letter submitted by current Head Judge Shannon Jungman to request that Brittany Bullard be the next Head Judge for 2026 – 2028.

She also mentioned that The Region 6 Student Symposium is <u>hosting a Naming Contest</u> for the future event name. Each student chapter member in Region 6 can vote in this bracket-style competition, coming this Fall. The name change will take effect in 2026.

Next, she mentioned the updates to the Region 6 Student Symposium Profit Share proposal since the last meeting. ExCom reviewed the document and provided a few small changes to be incorporated into the approved version.

Motion to approve the updated Region 6 Student Symposium Profit Sharing document as edited. Move to approve. Seconded and passed without dissent.

Lastly, she noted that the Texas Younger Member Committee is helping to host ASCE's Global YM Alumni Summit in Houston this Fall and that the Texas Section STEM Committee has a newly appointed chair, Nalah Williams PE.

3.4 Professional Activities

Discussion: VP Professional Andres Salazar PhD, PE gave a brief overview of the current activities of the Government Affairs and Texas IRC Committees. He also mentioned that the Subject Matter Experts Bureau has a newly appointed Chair, Travis Attanasio PE.

3.5 Technical Activities

Discussion: VP Technical Chris Nance PE provided a brief update on Institute Chapter involvement with CECON, noting that all the session selections and notifications have been completed. He also noted that there are five upcoming webinars that have been confirmed and will be up on the Texas Section website in July.

VP Technical Elect Mark Mann PE has received a handful of questions regarding the CECON Poster Sessions but has not received any official submissions as of today. The deadline is August 9.

3.6 Membership

Discussion: President Elect Boyd reviewed the current membership trends as of July 1 and noted that Texas Section Leaders and the Membership Committee have attended a few conferences across Texas.

Future Idea – use the profits from the Symposium to elevate that event and make it an even better experience for student attendees since it may be the first experience they have with ASCE.

3.7 Volunteer Recruiting

Discussion: President Cornett passed out the 2024-25 Committee Chairs list, noting that everyone on that list has been confirmed. She also noted that the Texas Section's annual Call for Volunteers for 2025 will run from mid-July to September.

Next, she noted that Brent McNeme has agreed to serve as the Membership Committee Co-Chair for 2024-45 alongside Clint Hoover.
