#### 3.1 **CECON 2024 Preliminary Report**

Discussion: CECON 2024 Co-Chair Stephen Archer PE gave a brief overview of the attendance and financial numbers from the event. He also congratulated and thanked the four Institute Chapter Chairs for their support and efforts in partnership with CECON.

#### 3.2 **Membership**

Discussion: President Elect Boyd noted that membership numbers are slightly increased from Sept 2023 -Sept 2024. Executive Director Peters mentioned the benefits of a deliberate local retention campaign as we approach the annual renewal window (Aug – Dec, late renew Jan - Mar). Huge potential for membership dues revenue capitalizing on Assigned members across the State (only 45% are subscribing!!).

#### 3.3 Texas Outstanding Faculty Advisor Award proposal by TCEF

Discussion: TCEF Board President Curtis Beitel explained the idea behind the Foundation's new individual annual award for faculty advisors. The goal would be to award this each year in Spring at Symposium. The winner will also be nominated for the ASCE Society Award.

The STEM Committee has plans to hold a similar event at CECON 2025 and they would also like to develop collaborations with other organizations. VP Educational Landry noted that the YM Committee just hosted a Tubing Trip (instead of a Camping Trip) and that it was success even though attendance was relatively small.
